

1 INTRODUCTION

The Office of the Controller of Budget (OCOB) is established under Article 228 of the Constitution of Kenya, 2010. It is mandated to oversee implementation of the budgets of the National and County Governments by authorizing withdrawals from public funds under Articles 204, 206 and 207, and reporting on the implementation of the budgets every four months.

This special budget implementation report is prepared for the Senate Ad Hoc Committee on COVID-19 in line with Article 254 (2) of the Constitution which requires the OCOB to prepare special reports at any time as may be required by the President or Parliament. The report is prepared in response to a letter from the Senate Ref: SEN/12/4/AC-COVID19/2020(58) dated 4th August 2020 which specified that the Ad Hoc Committee on COVID-19 Situation had resolved at its 73rd Sitting held on Wednesday, 29th July 2020, to request from the Controller of Budget, a Special Budget Review Implementation Report on the utilization of funds by County Governments towards COVID-19 interventions. The report covers the period from 13th March 2020 when the first COVID-19 case was reported in Kenya, to 31st July 2020 and provides an overview of utilization on COVID-19 funds by County Governments. Due to the short time-frame for the report, the figures are based on self-reporting by County Governments on how the funds for COVID-19 were received and utilized during the period under review.

The structure of the report is as follows: Chapter one captures the introduction while chapter two provides an analysis of the counties' cumulative funds and expenditure on COVID-19. The funds are summarized into funding from the National Government, Grants from Development Partners and County own contributions. Chapter three presents specific information on utilization of funds by county governments towards COVID-19 interventions. The key issues identified by the OCOB in the utilization of the COVID-19 funds and appropriate recommendations are provided in chapter four. Finally, the conclusion is offered in chapter five.

2 ANALYSIS OF COUNTIES' CUMULATIVE FUNDS AND EXPENDITURE ON COVID-19

2.1 Introduction

This chapter presents the analysis of aggregated county funds and expenditure on COVID-19 from 13th March 2020 when the first COVID-19 case was reported in Kenya, to 31st July 2020. The basis of this report is self-reporting by the County Governments on the utilisation of COVID-19 funds during the period under review.

2.2 Overall Revenue Out-turn

The total funds that were available from 13th March to 31st July 2020 to the County Governments for COVID-19 interventions amounted to **Kshs.13.1 billion**. This amount consisted of Kshs.5 billion from the National Government through the Ministry of Health (MOH) for COVID-19 towards quarantine and isolation expenditure, Kshs.2.36 billion from the National Government through (MOH) for allowances for Front Line Health Care Workers, Kshs.350 million from DANIDA as a grant support Level 2 and 3 Health Facilities to fight the pandemic, and Kshs.5.39 billion from county own funds (Refer to Annex 1). This report does not include the funds received directly by County Governments as donations.

Counties which had the highest funds allocated for COVID-19 activities were Turkana, Nakuru and Nairobi City at Kshs.858.19 million, Kshs.603.13 million and Kshs.576.67 million. Those with the lowest budget allocations were Lamu at Kshs.37.96 million, Tana River at Kshs.71.08 million and Taita Taveta at Kshs.76.79 million.

2.3 Overall Expenditure Analysis

The total expenditure by County Governments during the period was **Kshs.3.43 billion** and translated to an absorption rate of 33.2 per cent. The absorption rate is calculated as a percentage of actual expenditure to budgeted amount for COVID-19 during the period.

Counties which reported the highest expenditure were Nakuru at Kshs.311.97 million, Wajir at Kshs.255.33 million and Kiambu at Kshs.245.94 million. Seven Counties, namely, Bomet, Embu Kirinyaga, Lamu, Mandera, Marsabit and Nairobi City, did not report any expenditure towards COVID-19 interventions. Mombasa County had not provided a report on the utilization of COVID-19 funds by the time of finalizing this report.

A detailed analysis of the utilization of COVID-19 funds by each county is provided in chapter three.

3 UTILIZATION OF FUNDS BY COUNTY GOVERNMENTS TOWARDS COVID-19 INTERVENTIONS

3.1 Introduction

This section provides individual County reports on the utilization of funds towards COVID-19 interventions from 13th March 2020 to 31st July 2020. The basis of this report is self-reporting by County Governments on the utilisation of COVID-19 funds during the period under review. The 47 County Governments are presented in alphabetical order.

3.2 County Government of Baringo

Table 1 shows the implementation status on the utilization of COVID-19 funds from 13th March 2020, when the first COVID-19 was reported, to 31st July 2020 by Baringo County.

The County grant for COVID-19 of Kshs.84,341,000 was requested through the OCOB and transferred to the Special Purpose Account held at Central Bank of Kenya (CBK) and has not been utilized as of 31st July 2020.

The County allocated Kshs.115.2 million in the FY 2019/20 budget for COVID-19 intervention. However, the allocated amount was not withdrawn from the CRF and therefore there was no actual expenditure as of 31st July 2020.

The County had outstanding financial commitments amounting to Kshs.37.42 million as of 31st July 2020 which comprised of Kshs.32 million for setting up a 200-bed isolation unit and Kshs.5.42 million for biomedical engineering requirements.

3.4 County Government of Bungoma

The grants received in the West Pokot CRF account comprised of Kshs.75.29 million towards COVID-19 response and Kshs.33.62 million as allowances to front line health workers from the National Government, Ksh.5.5 million from DANIDA, and County allocation from internal funds of Kshs.25.16 million.

The County withdrew Kshs.25.16 million from the CRF Account during the period under review for operations which was entirely spent as shown in Table 116.

The available funds were used to build capacity for COVID-19 emergency response through training of Frontline Health Care Workers and community, repair of vehicles and purchase of sanitizers and thermoguns. Four County entry checkpoints were also established providing handwashing and temperature checking.

4 HIGHLIGHT OF KEY ISSUES AND RECOMMENDATIONS

4.1 Introduction

This section highlights cross-cutting issues that affected the utilization of COVID-19 Funds by County Governments from 13th March 2020 to 31st July 2020 and present recommendations aimed at addressing the challenges. The cross-cutting challenges included:

4.2 Failure by Counties to Budget for the COVID-19 Grants

The National Government grants of Kshs.5 billion for COVID -19 responses was transferred to the various County Revenue Fund Accounts on 4th June 2020 through the Ministry of Health. Counties further received Kshs.2.36 billion on 6th July 2020 from the National Government (Ministry of Health) being allowances for Frontline Health Care Workers dealing with COVID-19 pandemic and Kshs.350 million from DANIDA on 30th June 2020 for COVID-19 interventions. The timing of the funds release was too close to the end of the Financial Year 2019/20 and some County Governments did not prepare budgets for the utilization of the COVID-19 Grant from the National Government. Consequently, several County Governments could not withdraw these funds which have remained unutilized as of 31st July 2020.

The OCOB recommends that County Governments ensure the COVID-19 grants are factored in the FY 2020/21 budget estimates to facilitate approval of withdrawals and utilization of these funds in line with the guidelines by the Ministry of Health and DANIDA.

4.3 Lack of adequate support from the National Government

The OCOB has observed that, when the first COVID-19 case in Kenya was reported, there were no clear guidelines from the National Government on the role of Counties in the management and response to COVID-19 cases. Although several County Governments allocated funds within their budgets to fight the Pandemic, they were unable to utilize the funds due to lack of support and guidelines from the National Government Ministry of Health (MOH). The guidelines and expectations from the County Governments were only issued towards the end of May 2020.

The OCOB recommends that key national government institutions should support County Governments as they implement the budgets for COVID-19 in the current financial year to ensure the quality of services and goods being procured meet the set standards. Further, there should be standardized support in capacity building of medical personnel and on public sensitization activities on the COVID-19 pandemic.

4.4 Internal Audit of the utilization of COVID-19 Pandemic Funds

County Governments have put in place arrangements for conducting internal audits in line with Section 155 of the Public Finance Management Act, 2012. As of 31st July 2020, County Governments reported actual expenditures of **Kshs.3.43 billion** towards COVID-19 intervention programmes compared the available resource basket of **Kshs.13.1 billion**.

This expenditure on COVID-19 intervention is yet to be audited and the OCOB recommends that the County Internal Audit Committees and the National Treasury should conduct internal audits to give an assurance on value for money and whether the funds were utilized as required by law.

5 CONCLUSION

This is a special report to the Senate Ad Hoc Committee on COVID-19 in line with Article 254 (2) of the Constitution which requires the OCOB to prepare special reports at any time as may be required by the President or Parliament. The report is prepared in response to a letter from the Senate Ref: SEN/12/4/AC-COVID19/2020(58) dated 4th August 2020 which requested the Controller of Budget to prepare a Special Budget Review Implementation Report on the utilization of funds by County Governments towards COVID- 19 interventions and covers the period from 13th March 2020 to 31st July 2020. The report is based on self-reporting by County Governments on how the funds for COVID-19 were utilized during the period under review. This report does not include the funds received directly by County Governments as donations.

The total funds that was available to the County Governments from 13th March to 31st July 2020 for COVID-19 interventions as captured amounted to Kshs.13.1 billion. Total expenditures by County Governments during the period were Kshs.3.43 billion and translated to an absorption rate of 33.2 per cent. The absorption rate is calculated as a percentage of actual expenditure to budgeted amount for COVID-19 during the period. The low utilization of funds during the period was as a result of several issues which included a failure by Counties to budget for the COVID-19 Grants from the National Government as the funds were received towards the end of the FY 2019/20 and lack of adequate support by the National Government institution during the initial stages of the Pandemic.

The OCOB recommends that Counties ensure the current FY 2020/21 Budget Estimates provide for the Grants for COVID-19 to enhance utilization. Key National Government Institutions should provide support to Counties to ensure value for money as the Country fight the pandemic. Further, the Internal Audit function should actively monitor and audit the utilization of the COVID-19 funds to stem any misuse in good time.
